**PLEASE NOTE THE FOLLOWING IMPORTANT INFORMATION**

- Boat racks are hired at the paddlers own risk.
- The club and committee will not be held responsible for the loss of or damage to any equipment left at the boat rack area.
- **Each paddler MUST secure their own boat within their allocated rack.**

### FEE PAYMENTS

- **Paddlers must ensure that they use only their allocated rack.** “Squatters” will not be tolerated. Boats placed in the wrong racks will be impounded regardless of whether a boat rack has been paid for.
- A sticker system is in place to monitor boat rack allocations. Sticker(s) showing the rack number will be issued to each paddler on receipt of this form and proof of payment. We encourage you to also identify your boat with your CSA number (R30 per set). Additional stickers may be purchased at a cost of R4 per sticker.

- **All boats in racks MUST have a current membership year sticker placed on top of the back deck at the rudder’s end.** Stickers must be displayed on boats stored in the racks at all times. Boats without correct stickers may be removed from the racks and incur a **R640** handling and storage fee.

- All queries can be directed to office at info@dabulamanzi.co.za
- Boat rack fees must be paid up along with the current season’s registration fees **NO LATER than 31 MAY** of every year.
- Failure to settle all outstanding fees by 31 May will result in the impounding of all boats in unpaid racks, and the re-allocation of such racks.
- **A release fee of R640 will be levied for the return of each impounded boat.**
- Impounded boats must be claimed by **NO LATER** than 30 JUNE. Any boat unclaimed after 30 June may be sold at auction.

- The club reserves the right to auction all unclaimed impounded and unpaid for boats at the Boat Auction.

- All proceeds made by the club from the sale of impounded boats will be used to cover club expenses.

### ACCESS DISKS

- Access disks of members not paid up by 31 May will automatically be deactivated. This will exclude them from access to parking, change-rooms and boat racks.
- Access will be reactivated once proof of payment & all completed, signed and dated forms have been received.
