INDEMNITY AND USE OF EQUIPMENT

I, the undersigned, do hereby state and agree that:

1. I am aware of the potential dangers involved and to which I will be exposed by participating in canoeing and associated activities;
2. I am further aware the Dabulamanzi Canoe Club and its officers, committee, employees, sponsors and representatives, in organising and permitting my participation in such activities and in enforcing any safety measures in regards thereto, cannot and do not ensure my safety and/or the adequacy of such measures;
3. In particular, I am aware that the Dabulamanzi Canoe Club does not make use of or provide any lightning protection equipment or any other ancillary equipment of whatsoever nature and that participating in canoeing and associated activities could expose me to risk of injury or death. A lightning policy is however housed on the official club website and it is the responsibility of members and other users of the club facilities to familiarise themselves with it.
4. As such, I hereby agree to:
 - 4.1. participate in all canoeing and associated activities at my own sole risk and responsibility;
 - 4.2. exonerate the Dabulamanzi Canoe Club and/or all persons and bodies involved in the management of the Dabulamanzi Canoe Club from and indemnify them against any claim/s for any loss or damage which I or any others, including my dependants, may suffer as a result of any injury or death resulting from any act or omission on the part of such body or person (including lightning strikes), where and howsoever caused, whether due to negligence (including gross negligence) or otherwise;
 - 4.3. comply with all safety rules and or instructions in place from time to time.
5. I have read and understood the contents of this indemnity.
6. The use of Club equipment by new members is limited to a period of three (3) months. After the expiry of the three months period, a member is expected to acquire their own equipment.
7. Beginners are allowed access to equipment three (3) times only before they are required to sign up with the Club.
8. Beginners (adults and juniors) need to pre-book a canoe with the coach, Attila, via What'sApp 072 122 6013. He will allocate a boat and no exemption will be allowed to this rule.
9. On Saturdays, permission will be required in order to use a club boat from 7am to 9am.
10. On Saturdays, there is NO allowance for using a club boat other than with the club coach between 10am and 12pm.
11. It is compulsory for all paddlers under the age of 14 to wear a life jacket.
